PREPLANT: Broadcast 7 lbs. per 1,000 sq.ft. (305 lbs. per acre).

GROUNDCOVER: Broadcast at 5 lbs. per 1,000 sq.ft. (1/2 lb. per 100 sq.ft.)

FLOWERING SHRUBS & EVERGREENS: Sprinkle 1/4 cup evenly around dripline of plant and work into top 1 inch of soil.

NOTE: Liquid measuring cups are very close in estimating the weight of dry granular fertilizers.

Example: An 8 oz. (1 cup) measuring cup holds approximately 8 oz. (1/2 lb.) of dry granular fertilizer.
